AN ACT

To repeal sections 453.010, 453.070 and 453.080, RSMo 2000, relating to the adoption of foster children, and to enact in lieu thereof three new sections relating to the same subject.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 453.010, 453.070 and 453.080, RSMo 2000, are repealed and three
2 new sections enacted in lieu thereof, to be known as sections 453.010, 453.070 and 453.080, to
3 read as follows:

453.010. 1. Any person desiring to adopt another person as his or her child shall petition
2 the juvenile division of the circuit court of the county in which:

- 3 (1) The person seeking to adopt resides;
- 4 (2) The child sought to be adopted was born;
- 5 (3) The child is located at the time of the filing of the petition; or
- 6 (4) Either birth person resides.

7 2. A petition to adopt shall not be dismissed or denied on the grounds that the petitioner
8 is not domiciled or does not reside in any of the venues set forth in subdivision (2), (3) or (4) of
9 subsection 1 of this section.

10 3. If the person sought to be adopted is a child who is under the prior and continuing
11 jurisdiction of a court pursuant to the provision of chapter 211, RSMo, any person desiring to
12 adopt such person as his or her child shall petition the juvenile division of the circuit court which
13 has jurisdiction over the child for permission to adopt such person as his or her child. Upon
14 receipt of a motion from the petitioner and consent of the receiving court, the juvenile division
15 of the circuit court which has jurisdiction over the child may transfer jurisdiction to the juvenile

16 division of a circuit court within any of the alternative venues set forth in subsection 1 of this
17 section.

18 4. If the petitioner has a spouse living and competent to join in the petition, such spouse
19 may join therein, and in such case the adoption shall be by them jointly. If such a spouse does
20 not join the petition the court in its discretion may, after a hearing, order such joinder, and if such
21 order is not complied with may dismiss the petition.

22 5. Upon receipt of a properly filed petition, a court, as defined in this section, shall hear
23 such petition in a timely fashion. A court or any child-placing agency shall not deny or delay the
24 placement of a child for adoption when an approved family is available, regardless of the
25 approved family's residence or domicile. **The court shall expedite the placement of a child
26 for adoption pursuant to subsection 3 of this section.**

453.070. 1. Except as provided in subsection 5 of this section, no decree for the
2 adoption of a child under eighteen years of age shall be entered for the petitioner or petitioners
3 in such adoption as ordered by the juvenile court having jurisdiction, until a full investigation,
4 which includes an assessment of the adoptive parents, an appropriate postplacement assessment
5 and a summary of written reports as provided for in section 453.026, and any other pertinent
6 information relevant to whether the child is suitable for adoption by the petitioner and whether
7 the petitioner is suitable as a parent for the child, has been made. The report shall also include
8 a statement to the effect that the child has been considered as a potential subsidy recipient.

9 2. Such investigation shall be made, as directed by the court having jurisdiction, either
10 by the division of family services of the state department of social services, a juvenile court
11 officer, a licensed child-placement agency, a social worker licensed pursuant to chapter 337,
12 RSMo, or other suitable person appointed by the court. The results of such investigation shall
13 be embodied in a written report that shall be submitted to the court within ninety days of the
14 request for the investigation.

15 3. The department of social services, division of family services, shall develop rules and
16 regulations regarding the content of the assessment of the petitioner or petitioners. The content
17 of the assessment shall include but not be limited to, a report on the condition of the petitioner's
18 home and information on the petitioner's education, financial, marital, medical and psychological
19 status and criminal background check. If an assessment is conducted after August 28, 1997, but
20 prior to the promulgation of rules and regulations by the department concerning the contents of
21 such assessment, any discrepancy between the contents of the actual assessment and the contents
22 of the assessment required by department rule shall not be used as the sole basis for invalidating
23 an adoption. No rule or portion of a rule promulgated pursuant to the authority of this section
24 shall become effective unless it has been promulgated pursuant to the provisions of chapter 536,
25 RSMo.

26 4. The assessment of petitioner or petitioners shall be submitted to the petitioner and to
27 the court prior to the scheduled hearing of the adoptive petition.

28 5. In cases where the adoption or custody involves a child under eighteen years of age
29 that is the natural child of one of the petitioners and where all of the parents required by this
30 chapter to give consent to the adoption or transfer of custody have given such consent, the
31 juvenile court may waive the investigation and report, except the criminal background check, and
32 enter the decree for the adoption or order the transfer of custody without such investigation and
33 report.

34 6. In the case of an investigation and report made by the division of family services by
35 order of the court, the court may order the payment of a reasonable fee by the petitioner to cover
36 the costs of the investigation and report.

37 7. Any adult person or persons over the age of eighteen, who, as foster parent or parents,
38 have cared for a foster child continuously for a period of [twelve] **nine** months or more and
39 bonding has occurred as evidenced by the positive emotional and physical interaction between
40 the foster parent and child, may apply to such authorized agency for the placement of such child
41 with them for the purpose of adoption if the child is eligible for adoption. The agency and court
42 shall give preference and first consideration for adoptive placements to foster parents. However,
43 the final determination of the propriety of the adoption of such foster child shall be within the
44 sole discretion of the court.

 453.080. 1. The court shall conduct a hearing to determine whether the adoption shall
2 be finalized. During such hearing, the court shall ascertain whether:

3 (1) The person sought to be adopted, if a child, has been in the lawful and actual custody
4 of the petitioner for a period of at least six months prior to entry of the adoption decree; **except**
5 **that the six month period shall be waived if the person sought to be adopted is a child who**
6 **is under the prior and continuing jurisdiction of a court pursuant to chapter 211, RSMo,**
7 **and the person desiring to adopt the child is the child's current foster parent.** "Lawful and
8 actual custody" shall include a transfer of custody pursuant to the laws of this state, another state,
9 a territory of the United States, or another country;

10 (2) The court has received and reviewed a postplacement assessment on the monthly
11 contacts with the adoptive family pursuant to section 453.077, except for good cause shown in
12 the case of a child adopted from a foreign country;

13 (3) The court has received and reviewed an updated financial affidavit;

14 (4) The court has received the recommendations of the guardian ad litem and has
15 received and reviewed the recommendations of the person placing the child, the person making
16 the assessment and the person making the postplacement assessment;

17 (5) There is compliance with the uniform child custody jurisdiction act, sections 452.440

18 to 452.550, RSMo;

19 (6) There is compliance with the Indian Child Welfare Act, if applicable;

20 (7) There is compliance with the Interstate Compact on the Placement of Children
21 pursuant to section 210.620, RSMo; and

22 (8) It is fit and proper that such adoption should be made.

23 2. If a petition for adoption has been filed pursuant to section 453.010 and a transfer of
24 custody has occurred pursuant to section 453.110, the court may authorize the filing for
25 finalization in another state if the adoptive parents are domiciled in that state.

26 3. If the court determines the adoption should be finalized, a decree shall be issued
27 setting forth the facts and ordering that from the date of the decree the adoptee shall be for all
28 legal intents and purposes the child of the petitioner or petitioners. The court may decree that
29 the name of the person sought to be adopted be changed, according to the prayer of the petition.

30 4. Before the completion of an adoption, the exchange of information among the parties
31 shall be at the discretion of the parties. Upon completion of an adoption, further contact among
32 the parties shall be at the discretion of the adoptive parents. The court shall not have jurisdiction
33 to deny continuing contact between the adopted person and the birth parent, or an adoptive parent
34 and a birth parent. Additionally, the court shall not have jurisdiction to deny an exchange of
35 identifying information between an adoptive parent and a birth parent.
