## AN ACT

To amend chapter 144, RSMo, relating to sales and use tax by adding thereto one new section relating to the same subject, with an emergency clause.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 144, RSMo, is amended by adding thereto one new section, to be known as section 144.520, to read as follows:

144.520. In addition to the exemptions granted pursuant to section 144.030, for the

Section B. Because immediate action is necessary to preserve commercial and industrial businesses operating within this state section A of this act is deemed necessary for the immediate preservation of the public health, welfare, peace and safety, and is hereby declared to be an emergency act within the meaning of the constitution, and section A of this act shall be in full force and effect upon its passage and approval.
