AN ACT

To amend chapter 208, RSMo, by adding thereto one new section relating to a Medicaid pharmacy management program, with an emergency clause.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 208, RSMo, is amended by adding thereto one new section, to be
2 known as section 208.560, to read as follows:

208.560. 1. The department of social services shall develop a comprehensive
2 **"Medicaid Pharmacy Management Program". The program shall have the following**
3 **duties related to pharmaceutical coverage under the state Medicaid program:**
4 **(1) Provide daily direction and be primarily responsible for the performance of the**
5 **Medicaid pharmacy program;**
6 **(2) Supervise all cost containment programs;**
7 **(3) Solicit Medicaid provider recommendations for best management practices;**
8 **(4) Enter into contracts for consultative services;**
9 **(5) Employ a program director;**
10 **(6) Employ experienced primary care physicians as a medical director and**
11 **additional support physicians for medical oversight;**
12 **(7) Employ pharmacists with clinical and practical experience;**
13 **(8) Employ support personnel;**
14 **(9) Provide personnel support and other resources for a disease state management**
15 **program;**
16 **(10) Include, as appropriate, management programs for subgroups, including but**
17 **not limited to the disabled and the elderly;**

18 **(11) Expand when legislatively directed to manage the state's MC+ program's and**
19 **the Missouri consolidated health care plan's pharmacy programs; and**

20 **(12) Report to the joint committee on pharmacy management established in**
21 **subsection 2 of this section quarterly or upon request.**

22 **2. There is hereby established a "Joint Committee on Pharmacy Management"**
23 **which shall be comprised of six members of the general assembly. Three members of the**
24 **bipartisan committee shall be appointed by the speaker of the house of representatives,**
25 **three members shall be appointed by the president pro tem of the senate. From the**
26 **members appointed, one member from each house of the general assembly shall be chosen**
27 **to serve as co-chairpersons of the committee. The members of the committee shall serve**
28 **without compensation but shall be reimbursed for their actual and necessary expenses**
29 **incurred in the performance of their official duties for the committee. The committee shall**
30 **review the effectiveness of the Medicaid pharmacy management program.**

 Section B. Because immediate action is necessary to ensure the availability of Medicaid
2 pharmaceutical funding section A of this act is deemed necessary for the immediate preservation
3 of the public health, welfare, peace and safety, and is hereby declared to be an emergency act
4 within the meaning of the constitution, and section A of this act shall be in full force and effect
5 upon its passage and approval.
