AN ACT

To repeal section 211.031, RSMo, and to enact in lieu thereof one new section relating to juvenile courts.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 211.031, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 211.031, to read as follows:

211.031. 1. Except as otherwise provided in this chapter, the juvenile court or the family court in circuits that have a family court as provided in sections 487.010 to 487.190, RSMo, shall have exclusive original jurisdiction in proceedings:

(1) Involving any child or person seventeen years of age who may be a resident of or found within the county and who is alleged to be in need of care and treatment because:

(a) The parents, or other persons legally responsible for the care and support of the child or person seventeen years of age, neglect or refuse to provide proper support, education which is required by law, medical, surgical or other care necessary for his or her well-being; except that reliance by a parent, guardian or custodian upon remedial treatment other than medical or surgical treatment for a child or person seventeen years of age shall not be construed as neglect when the treatment is recognized or permitted pursuant to the laws of this state;

(b) The child or person seventeen years of age is otherwise without proper care, custody or support; or

(c) The child or person seventeen years of age was living in a room, building or other structure at the time such dwelling was found by a court of competent jurisdiction to be a public nuisance pursuant to section 195.130, RSMo;

EXPLANATION — Matter enclosed in bold faced brackets [thus] in this bill is not enacted and is intended to be omitted in the law.

17 (2) Involving any child who may be a resident of or found within the county and who is
18 alleged to be in need of care and treatment because:

19 (a) The child while subject to compulsory school attendance is repeatedly and without
20 justification absent from school; or

21 (b) The child disobeys the reasonable and lawful directions of his or her parents or other
22 custodian and is beyond their control; or

23 (c) The child is habitually absent from his or her home without sufficient cause,
24 permission, or justification; or

25 (d) The behavior or associations of the child are otherwise injurious to his or her welfare
26 or to the welfare of others; or

27 (e) The child is charged with an offense not classified as criminal, or with an offense
28 applicable only to children; except that, the juvenile court shall not have jurisdiction over any
29 child fifteen [and one-half] years of age who is alleged to have violated a state or municipal
30 traffic ordinance or regulation, the violation of which does not constitute a felony[, or any child
31 who is alleged to have violated a state or municipal ordinance or regulation prohibiting
32 possession or use of any tobacco product];

33 (3) Involving any child who is alleged to have violated a state law or municipal
34 ordinance, or any person who is alleged to have violated a state law or municipal ordinance prior
35 to attaining the age of seventeen years, in which cases jurisdiction may be taken by the court of
36 the circuit in which the child or person resides or may be found or in which the violation is
37 alleged to have occurred; except that, the juvenile court shall not have jurisdiction over any child
38 fifteen [and one-half] years of age who is alleged to have violated a state or municipal traffic
39 ordinance or regulation, the violation of which does not constitute a felony[, or any child who
40 is alleged to have violated a state or municipal ordinance or regulation prohibiting possession
41 or use of any tobacco product];

42 (4) For the adoption of a person;

43 (5) For the commitment of a child or person seventeen years of age to the guardianship
44 of the department of social services as provided by law.

45 2. Transfer of a matter, proceeding, jurisdiction or supervision for a child or person
46 seventeen years of age who resides in a county of this state shall be made as follows:

47 (1) Prior to the filing of a petition and upon request of any party or at the discretion of
48 the juvenile officer, the matter in the interest of a child or person seventeen years of age may be
49 transferred by the juvenile officer, with the prior consent of the juvenile officer of the receiving
50 court, to the county of the child's residence or the residence of the person seventeen years of age
51 for future action;

52 (2) Upon the motion of any party or on its own motion prior to final disposition on the

53 pending matter, the court in which a proceeding is commenced may transfer the proceeding of
54 a child or person seventeen years of age to the court located in the county of the child's residence
55 or the residence of the person seventeen years of age, or the county in which the offense pursuant
56 to subdivision (3) of subsection 1 of this section is alleged to have occurred for further action;

57 (3) Upon motion of any party or on its own motion, the court in which jurisdiction has
58 been taken pursuant to subsection 1 of this section may at any time thereafter transfer jurisdiction
59 of a child or person seventeen years of age to the court located in the county of the child's
60 residence or the residence of the person seventeen years of age for further action with the prior
61 consent of the receiving court;

62 (4) Upon motion of any party or upon its own motion at any time following a judgment
63 of disposition or treatment pursuant to section 211.181, the court having jurisdiction of the cause
64 may place the child or person seventeen years of age under the supervision of another juvenile
65 court within or without the state pursuant to section 210.570, RSMo, with the consent of the
66 receiving court;

67 (5) Upon the transfer of any matter, proceeding, jurisdiction or supervision of a child or
68 person seventeen years of age, certified copies of all legal and social documents and records
69 pertaining to the case on file with the clerk of the transferring juvenile court shall accompany the
70 transfer.

71 3. In any proceeding involving any child or person seventeen years of age taken into
72 custody in a county other than the county of the child's residence or the residence of a person
73 seventeen years of age, the juvenile court of the county of the child's residence or the residence
74 of a person seventeen years of age shall be notified of such taking into custody within
75 seventy-two hours.
