AN ACT

To repeal sections 386.120 and 386.210, RSMo, and to enact in lieu thereof fifteen new sections relating to the regulation of electric, gas, and water utilities, with penalty provisions.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 386.120 and 386.210, RSMo, are repealed and fifteen new sections
2 enacted in lieu thereof, to be known as sections 386.120, 386.135, 386.210, 386.374, 386.900,
3 393.156, 393.158, 393.1000, 393.1003, 393.1006, 393.1009, 393.1012, 393.1015, 393.1018,
4 and 1, to read as follows:

2 386.120. 1. The principal office of the commission shall be at the state capital at the city
2 of Jefferson City. The commissioners shall reside within [a forty-mile radius of the city of
3 Jefferson City] **the state of Missouri** during their respective terms of office. The office required
4 by this subsection shall be provided and assigned by the board of public buildings.

5 2. The commission shall at all times, except Saturdays, Sundays and legal holidays, be
6 open and in session for the transaction of business and the commissioners shall devote their
7 entire time to the duties of their office.

8 3. The commission shall have an official seal bearing the following inscription: "Public

EXPLANATION — Matter enclosed in bold faced brackets [thus] in this bill is not enacted and is intended to be omitted in the law. Matter in boldface type in the above law is proposed language.

9 Service Commission of the State of Missouri". The seal shall be affixed to all writs and
10 authentications of copies of records and to such other instruments as the commission shall direct.
11 All courts shall take judicial notice of such seal.

12 4. The commission may sue and be sued in its official name. The offices of said
13 commission shall be supplied with all necessary books, maps, charts, stationery, office furniture,
14 telephone and telegraph connections, and all other necessary appliances and incidentals, to be
15 paid for in the same manner as other expenses authorized by this chapter.

16 5. The offices of the commission shall be open during business hours on all days except
17 Saturdays, Sundays and legal holidays, and one or more responsible persons, designated by the
18 commission or by the secretary, under the direction of the commission, shall be on duty at all
19 times, in immediate charge thereof.

20 6. Any summons or other writ issued by any court of this state or of the federal
21 government shall be served upon the secretary of the commission or on any commissioner at the
22 principal office of the commission in Jefferson City. Service of any summons or other writ upon
23 the secretary of the commission, or upon any single commissioner, shall constitute service upon
24 the entire commission.

**386.135. 1. The commission shall have an independent technical advisory staff of
2 six full time employees. The advisory staff shall have expertise in one or more of the
3 following fields: accounting, economics, finance, engineering, utility operations, law or
4 public policy.**

5 **2. In addition, each commissioner shall also have the authority to retain one
6 personal advisor, who shall be deemed a member of the technical advisory staff. The
7 personal advisors will serve at the pleasure of the individual commissioner whom they
8 serve and shall possess expertise in one or more of the following fields: accounting,
9 economics, finance, engineering, utility operations, law or public policy.**

10 **3. The commission may only hire technical advisory staff pursuant to subsections
11 1 and 2 if there is a corresponding elimination in comparable staff positions for commission
12 staff to offset the hiring of such technical advisory staff on a cost neutral basis. Such
13 technical advisory staff shall be hired on or before July 1, 2004.**

14 **4. It shall be the duty of the technical advisory staff to render advice and assistance
15 to the commissioners and the commission's hearing officers on technical matters within
16 their respective areas of expertise that may arise during the course of proceedings before
17 the commission.**

18 **5. The technical advisory staff shall also update the commission and the
19 commission's hearing officers periodically on developments and trends in public utility
20 regulation, including updates comparing the use, nature, and effect of various regulatory**

21 **practices and procedures as employed by the commission and public utility commissions**
22 **in other jurisdictions.**

23 **6. Each member of the technical advisory staff shall be subject to any applicable**
24 **ex parte or conflict of interest requirements in the same manner and to the same degree as**
25 **any commissioner, provided that neither any person regulated by, appearing before, or**
26 **employed by the commission shall be permitted to offer such member a different**
27 **appointment or position during that member's tenure on the technical advisory staff.**

28 **7. No employee of a company or corporation regulated by the public service**
29 **commission, no employee of the office of public counsel or the public counsel, and no staff**
30 **members of either the utility operations division or utility services division, who, were**
31 **employees or staff members on, during the two years immediately preceding, or anytime**
32 **after August 28, 2003, may be a member of the commission's technical advisory staff for**
33 **two years following the termination of their employment with the corporation, office of**
34 **public counsel, or commission staff member.**

35 **8. The technical advisory staff shall never be a party to any case before the**
36 **commission.**

386.210. 1. The commission may confer in person, or by correspondence, by attending
2 conventions, or in any other way, with the members of **the public**, any public utility or similar
3 commission of **this and** other states and the United States of America, or any official, agency
4 or instrumentality thereof, on any matter relating to the performance of its duties.

5 **2. Such communications may address any issue that at the time of such**
6 **communication is not the subject of a case that has been filed with the commission.**

7 **3. Such communications may also address substantive or procedural matters that**
8 **are the subject of a pending filing or case in which no evidentiary hearing has been**
9 **scheduled, provided that the communication:**

10 **(1) Is made at a public agenda meeting of the commission where such matter has**
11 **been posted in advance as an item for discussion or decision;**

12 **(2) Is made at a forum where representatives of the public utility affected thereby,**
13 **the office of public counsel, and any other party to the case are present; or**

14 **(3) If made outside such agenda meeting or forum, is subsequently disclosed to the**
15 **public utility, the office of the public counsel, and any other party to the case in accordance**
16 **with the following procedure:**

17 **(a) If the communication is written, the person or party making the communication**
18 **shall no later than the next business day following the communication, file a copy of the**
19 **written communication in the official case file of the pending filing or case and serve it**
20 **upon all parties of record;**

21 **(b) If the communication is oral, the party making the oral communication shall,**
22 **no later than the next business day following the communication, file a memorandum in**
23 **the official case file of the pending case disclosing the communication and serve such**
24 **memorandum on all parties of record. The memorandum shall contain a summary of the**
25 **substance of the communication and not merely a listing of the subjects covered.**

26 **4. Nothing in this section or any other provision of law shall be construed as**
27 **imposing any limitation on the free exchange of ideas, views, and information between any**
28 **person and the commission or any commissioner, provided that such communications**
29 **relate to matters of general regulatory policy and do not address the merits of the specific**
30 **facts, evidence, claims, or positions presented or taken in a pending case unless such**
31 **communications comply with the provisions of subsection 3 of this section.**

32 **5. The commission and any commissioner may also advise any member of the**
33 **general assembly or other governmental official of the issues or factual allegations that are**
34 **the subject of a pending case, provided that the commission or commissioner does not**
35 **express an opinion as to the merits of such issues or allegations, and may discuss in a public**
36 **agenda meeting with parties to a case in which an evidentiary hearing has been scheduled,**
37 **any procedural matter in such case or any matter relating to a unanimous stipulation or**
38 **agreement resolving all of the issues in such case.**

39 [2.] **6.** The commission may enter into and establish fair and equitable cooperative
40 agreements or contracts with or act as an agent or licensee for the United States of America, or
41 any official, agency or instrumentality thereof, or any public utility or similar commission of
42 other states, that are proper, expedient, fair, and equitable and in the interest of the state of
43 Missouri and the citizens thereof, for the purpose of carrying out its duties [under] **pursuant to**
44 **section 386.250 as limited and supplemented by section 386.030 and to that end the commission**
45 **may receive and disburse any contributions, grants or other financial assistance as a result of or**
46 **pursuant to such agreements or contracts. Any contributions, grants or other financial assistance**
47 **so received shall be deposited in the public service commission utility fund or the state highway**
48 **commission fund depending upon the purposes for which they are received.**

49 [3.] **7.** The commission may make joint investigations, hold joint hearings within or
50 without the state, and issue joint or concurrent orders in conjunction or concurrence with any
51 railroad, public utility or similar commission, of other states or the United States of America, or
52 any official, agency or any instrumentality thereof, except that in the holding of such
53 investigations or hearings, or in the making of such orders, the commission shall function under
54 agreements or contracts between states or under the concurrent power of states to regulate
55 interstate commerce, or as an agent of the United States of America, or any official, agency or
56 instrumentality thereof, or otherwise.

386.374. Notwithstanding any other provisions of this chapter or any law to the contrary, the public service commission may approve, upon the terms and conditions in an application, tariff or settlement agreement proposed or recommended by an electric or gas corporation, programs for assisting low-income residential ratepayers in obtaining or maintaining access to reliable, continuous utility service to such low-income utility customers. The commission may also approve energy efficiency, weatherization, and evaluation components as part of such programs. All programs, tariffs, agreements, or rule provisions that provide for such assistance shall include terms for adjusting rates as necessary to ensure that the program, tariff, agreement, or rule provision will not have any negative financial impact on the electric or gas corporation. Nothing in this section shall be construed as diminishing the commission's existing authority to approve on an experimental basis low-income assistance programs proposed by an electric or gas corporation.

386.900. 1. Any person or other entity that has or acquires a legal or equitable interest of five percent ownership or greater of both:

- (1) A public utility subject to regulation by the commission; and**
- (2) Any corporation or other entity that supplies products, including but not limited to energy, gas, electricity, coal, and nuclear fuel, or services to such public utility of more than one million dollars per year;**

shall give notice, in writing, to the commission within thirty days of acquiring such a double interest. Any individual or entity holding such an interest as of August 28, 2003, shall provide notice to the commission pursuant to this section within thirty days of August 28, 2003.

2. Violation of subsection 1 of this section shall be a class A misdemeanor. In the event that the commission or any other agency of this state becomes aware of a violation of subsection 1 of this section, such violation shall immediately be reported to the attorney general for prosecution.

393.156. 1. As used in this section, the following terms mean:

(1) "Company", an electrical corporation or a gas corporation;

(2) "Contract", a company's contract for the purchase of electrical power and energy in the amount of five million dollars or more;

(3) "Cost", the total actual installed cost of a facility, including allowance for funds used during construction, found by the commission to be prudent and used and useful in the provision of retail service to customers or the cost of a contract found by the commission to be prudent;

9 (4) "Facility", any electric plant or gas plant with an estimated total investment or
10 leased cost of five million dollars or more for companies serving one hundred thousand to
11 one million customers in this state, and twenty-five million dollars or more for those
12 companies serving more than one million customers in this state;

13 (5) "In-service date", the date upon which the facility meets commission approved
14 in-service criteria consistent with section 393.135;

15 (6) "In-service criteria", those operation and performance criteria utilized by the
16 commission, consistent with section 393.135, to determine that the facility will be fully
17 operational and used for service;

18 (7) "Ratemaking principles", may include authorized return on common equity,
19 minimum equity levels and maximum long term debt levels to finance the facility,
20 estimated service life except that gas-fired generation built after January 2003, shall have
21 twenty year service life and coal-fired generation built after January 2003, shall have
22 thirty-five year service life, depreciation rate for cost of service purposes except that gas-
23 fired generation built after January 2003, shall have a depreciation rate of five percent and
24 coal-fired generation built after January 2003, shall have a depreciation rate of two and
25 eighty-sixth hundredths percent, jurisdictional allocation method to be applied to the
26 facility cost and facility in-service criteria;

27 (8) "Stake", a company's whole or fractional ownership share or leasehold, or
28 other proprietary interest in a facility.

29 2. Prior to undertaking the construction of, or participation in, a facility or prior
30 to entering into a contract, a company may file with the commission an application
31 requesting a determination of the ratemaking principles that will apply to the cost to be
32 incurred by the company to acquire its stake in the facility during the expected useful life
33 of the facility, or to the cost of the contract during the term thereof.

34 3. Prepared direct testimony and exhibits supporting the company's application
35 shall be filed at the same time as the application. A minimum of two copies of said
36 documents shall be served on the office of the public counsel on the same date. If the
37 facility is not to be located within the state of Missouri or the contract is not with an entity
38 owning generation facilities within the state of Missouri, the company shall establish that
39 the location for the facility or the contract is in the best interest of Missouri ratepayers and
40 shall give preference to facilities to be located within the state of Missouri.

41 4. Public notice and intervention shall be allowed.

42 5. The commission shall thereafter issue an order setting forth the ratemaking
43 principles that will be applicable to the cost of the company's stake in the facility or to the
44 cost of the contract in all ratemaking proceedings before the commission on and after such

45 time as the facility is fully operational and used for service or the effective date of the
46 contract. The ratemaking principles applicable to the cost of the facility or cost of the
47 contract shall be utilized by the commission in all proceedings before it in which the cost
48 of the company's stake in the facility or the cost of the contract is considered. If the
49 commission fails to issue a determination within one hundred eighty days of the date an
50 application for a determination of ratemaking principles is filed, the ratemaking principles
51 proposed by the company in its application will be deemed to have been approved by the
52 commission and shall be binding for ratemaking purposes during the useful life of the
53 facility or during the term of the contract. An application pursuant to this section may, at
54 the option of the company, be joined with and made a part of an application for a
55 certificate of convenience and necessity under section 393.170, if necessary, in which case
56 the application for a certificate of convenience and necessity will be deemed to have been
57 approved by the commission if not otherwise decided within one hundred eighty days after
58 the application is filed.

59 6. The company shall have twelve months from the effective date of the
60 determination to notify the commission whether it will construct, or participate in the
61 construction of, the facility or whether it will enter into the contract. If the company
62 notifies the commission within the twelve-month period that the company will not
63 construct, or participate in the construction of, the facility or that it will not enter into the
64 contract, then the determination of ratemaking principles pursuant to subsection 5 of this
65 section shall be of no further force or effect, and shall have no precedential value in any
66 subsequent proceeding before the commission, and there shall be no adverse presumption
67 applied to the company in any future proceeding before the commission as a result of such
68 notification.

69 7. Nothing herein shall excuse a company from complying with its public service
70 obligation to provide safe and adequate service at just and reasonable rates.

393.158. 1. As used in this section, the following terms mean:

2 (1) "Base cost", the average cost of fuel and purchased power energy costs per
3 kilowatt hour included in base rates at the time of the last general retail rate proceeding;

4 (2) "Commission", the Missouri public service commission;

5 (3) "Correction amount", the dollar cost, positive or negative, needed to adjust the
6 second prior month's energy cost estimate to the actual cost incurred during the second
7 prior month. The correction amount shall be calculated as follows: the sum of the actual
8 cost of fuel burned during the correction month, the actual cost of purchased power
9 incurred during the correction month, the actual net cost of interchange during the
10 correction month, and the correction amount used originally in the correction month;

11 minus the sum of the estimated cost of fuel burned during the correction month, estimated
12 cost of purchased power during the correction month, the estimated net cost of interchange
13 during the correction month and the correction amount used originally in energy cost
14 adjustment clause calculation for the second prior month. The net result is multiplied by
15 the ratio of actual kilowatt hour sales in the correction month over the estimated kilowatt
16 hour sales in the correction month;

17 (4) "FERC", the Federal Energy Regulatory Commission;

18 (5) "Fuel", the amount paid by an electrical corporation for natural gas, oil, or
19 coal, including the transportation thereof, used by said corporation or another entity to
20 generate for or to supply electrical energy to said corporation;

21 (6) "Net interchange", the net dollar cost, positive or negative, of interchange
22 received less interchange sales;

23 (7) "Purchased power", the amount paid by an electrical corporation for electrical
24 energy, including the transmission thereof, generated by another entity, but used by said
25 electrical corporation, and the delivered cost of natural gas burned in tolling purchased
26 power contracts;

27 (8) "Sales", the estimated kilowatt hours delivered to customers during the current
28 month, which equals the sum of the estimated kilowatt hours generated, purchased and net
29 interchanged during the month multiplied by one minus the line loss percentage.

30 2. Notwithstanding any other provision of the law to the contrary, any electrical
31 corporation, as defined in section 386.020, RSMo, shall be allowed to recover all of its
32 reasonably and prudently incurred costs for fuel and all of its reasonably and prudently
33 incurred costs for purchased electrical energy for its retail customers through energy
34 adjustment rate schedules designed to specifically recover such costs. The energy
35 adjustment rate schedules to recover these costs shall be filed with the commission, and
36 may, at the option of the electrical corporation, be established and implemented either
37 within or without the context of a general rate increase request proceeding. However, in
38 the event the electrical corporation seeks to establish and implement energy adjustment
39 rate schedules outside the context of a general rate increase proceeding, the commission
40 shall determine the level of fuel costs contained in the electrical corporation's existing filed
41 and approved base rates based on detailed records, work papers, calculations, or other
42 information and materials provided to the commission.

43 3. The commission shall allow the modification of the energy adjustment rate
44 schedules authorized by this section to take place on a timely basis to reflect increases or
45 decreases in fuel costs and purchased energy costs above or below the costs of said items
46 reflected in the permanent base rates of the electrical corporation on file with and

47 approved by the commission. Changes in such energy adjustment rate schedules may be
48 made as frequently as every ninety days. In exercising its authority pursuant to this
49 section, the commission shall consider only whether the calculations of said fuel costs and
50 purchased energy costs by the electrical corporation are accurate and reflect the costs
51 being incurred or reasonably expected to be incurred by the electrical corporation and the
52 commission shall not, at the same time, consider other factors which may affect the other
53 costs or the overall rates or other charges of such electrical corporation.

54 4. In connection with implementing the energy adjustment rate schedules
55 authorized pursuant to this section, the commission shall establish a "true-up" procedure
56 similar to the procedure that the commission utilizes for purchased gas cost recovery for
57 gas corporations. The "true-up" procedure shall accurately and appropriately remedy any
58 over or under collections of the involved costs from previous periods, including any over
59 or under collection of the fuel costs and electrical energy costs embedded in the
60 corporation's rates that were not reflected in the commission's initial determination of
61 these costs pursuant to subsection 9 of this section with customer credits or refunds
62 including interest payable at the electrical corporation's short-term debt rate. The true-up
63 procedure shall also be used to evaluate whether, and to what extent, the involved costs
64 were prudently incurred and to make any rate adjustments necessary to exclude costs that
65 were not prudently incurred to the financial detriment of the electric corporation's
66 customers.

67 5. Fuel costs recoverable pursuant to this section shall include only those costs
68 properly recorded as fuel costs, including pipeline delivery charges, prior to or in the
69 burning cycle in FERC Account Numbers 501, 547, or 555, except that said costs shall be
70 reduced by the amount of supplier or pipeline refunds normally credited to said accounts.
71 Purchased electrical energy costs recoverable pursuant to this section shall include those
72 properly recorded as purchased energy costs, including related transmission charges
73 incurred for delivery of the purchased energy, in FERC Account Numbers 555 or 565,
74 exclusive of capacity, demand or other fixed charges.

75 6. Each electrical corporation, which has on file with the commission approved
76 energy adjustment rate schedules pursuant to this section, shall submit to the commission
77 on or before the fifteenth day of each month an energy adjustment report, in a format
78 prescribed by the commission, showing the calculations for the next month's energy
79 adjustment rate.

80 7. The energy adjustment rates authorized by this section when modified shall be
81 increased or decreased by one-tenth of one cent per kilowatt hour for each one-tenth of one
82 cent, or major fraction thereof, increase or decrease in the aggregate cost of energy per

83 kilowatt hour computed by the following formula: The sum of the estimated cost of fuel
84 burned during the current month, the estimated total cost of purchased power incurred
85 during the current month, the estimated net cost of interchange incurred during the
86 current month, and the correction amount divided by estimated sales during the current
87 month, minus the base cost of energy.

88 **8. Each energy adjustment rate schedule filing made pursuant to this section shall**
89 **include detailed records, work papers, and calculations sufficient for the commission to**
90 **determine whether to establish, continue, reduce, or increase the level of the energy**
91 **adjustment rate. Copies of all such filings shall be provided on the same calendar day to**
92 **the office of the public counsel.**

93 **9. Energy adjustment rate schedule filings pursuant to this section shall be designed**
94 **to become effective thirty days after filing and not be subject to suspension by the**
95 **commission. Any such filing shall be considered on an expedited basis and a decision,**
96 **including an initial determination, if necessary, of the fuel costs and purchased electrical**
97 **energy costs embedded in the corporation's base rates, shall be made by the commission**
98 **within thirty days of the filing. Interested parties may intervene in any such proceedings,**
99 **but any such intervention shall not extend the thirty-day period for making a decision.**
100 **The energy adjustment rate schedules shall become effective the date of said commission**
101 **decision or thirty days after filing, whichever first occurs, but shall be subject to the "true-**
102 **up" mechanism described in subsection 4 of this section.**

103 **10. Nothing in this section shall allow an electrical corporation to avoid any rate**
104 **freeze conditions or other commitments made in connection with settlements of any prior**
105 **general rate proceeding.**

106 **11. Nothing in this section shall be construed as limiting the authority of the**
107 **commission to review and consider fuel costs, purchased electrical energy costs, or any**
108 **other fuel or fuel-related costs along with other costs during any general rate proceeding**
109 **of any electrical corporation.**

110 **12. Nothing in this section shall be construed as limiting the authority of the**
111 **commission to continue the practice of using the purchased gas adjustment clause**
112 **mechanism for the recovery of natural gas commodity, transportation, storage, and related**
113 **costs for gas corporations whereby changes in such costs are recognized in rates without**
114 **the filing of a general rate proceeding.**

115 **13. In the event that the estimate total energy costs per kWh for any quarter**
116 **exceeds by more than 5% the actual cost per kWh for that quarter, the utility shall submit**
117 **an explanation. If the utility cannot show that the estimate was realistic and the actual**
118 **costs was the lowest overall cost that could be been incurred, the commission may, at its**

119 **discretion, assess the utility for the purpose of recovering administrative costs of handling**
120 **the adjustment, in an amount not to exceed the difference between the amount billed to**
121 **customers under the estimated rate and the actual increase in energy costs for those billing**
122 **periods.**

123 **14. Any electricity generated with proceeds from the fuel adjustment charge shall**
124 **not subsidize the generation of electricity to be used for resale on the wholesale market.**
125 **Therefore, this subsidized generation must be used in the state of Missouri.**

126 **15. The provisions of this section shall expire on August 28, 2008.**

393.1000. As used in sections 393.1000 to 393.1006, the following terms mean:

2 **(1) "Appropriate pretax revenues", the revenues necessary to produce net**
3 **operating income equal to:**

4 **(a) The water corporation's weighted cost of capital multiplied by the net original**
5 **cost of eligible infrastructure system replacements, including recognition of accumulated**
6 **depreciation and deferred income taxes associated with eligible infrastructure system**
7 **replacements which are included in a currently effective ISRS; and**

8 **(b) Recover state, federal, and local income or excise taxes applicable to such**
9 **income; and**

10 **(c) Recover all other ISRS costs;**

11 **(2) "Commission", the Missouri public service commission;**

12 **(3) "Eligible infrastructure system replacements", water utility plant projects that:**

13 **(a) Replace or extend the useful life of existing infrastructure;**

14 **(b) Are in service and used and useful;**

15 **(c) Do not increase revenues by directly connecting the infrastructure replacement**
16 **to new customers; and**

17 **(d) Were not included in the water corporation's rate base in its most recent**
18 **general rate case;**

19 **(4) "ISRS", infrastructure system replacement surcharge;**

20 **(5) "ISRS costs", depreciation expenses, and property taxes that will be due within**
21 **twelve months of the ISRS filing;**

22 **(6) "ISRS revenues", revenues produced through an ISRS, exclusive of revenues**
23 **from all other rates and charges;**

24 **(7) "Water corporation", every corporation, company, association, joint stock**
25 **company or association, partnership, and person, their lessees, trustees, or receivers**
26 **appointed by any court whatsoever, owning, operating, controlling, or managing any plant**
27 **or property, dam or water supply, canal, or power station, distributing or selling for**
28 **distribution, or selling or supplying for gain any water to more than ten thousand**

29 customers which the public service commission has jurisdictional authority pursuant to
30 chapter 386, RSMo;

31 (8) "Water utility plant projects", may consist only of the following:

32 (a) Mains, and associated valves and hydrants, installed as replacements for
33 existing facilities that have worn out or are in deteriorated condition;

34 (b) Main cleaning and relining projects; and

35 (c) Facilities relocations required due to construction or improvement of a highway,
36 road, street, public way, or other public work by or on behalf of the United States, this
37 state, a political subdivision of this state, or another entity having the power of eminent

2 electric corporation, gas corporation, or water corporation to recover the utility's
3 incremental costs of prudent expenditures for security measures incurred after September
4 11, 2001, and reasonably required to comply with requirements or guidelines of the United
5 States Department of Energy, the United States Environmental Protection Agency, the
6 Federal Bureau of Investigation, the United States Department of Homeland Security, the
7 Nuclear Regulatory Commission, the Federal Energy Regulatory Commission, the North
8 American Reliability Council, the Office of Pipeline Safety within the United States
9 Department of Transportation, the state office of homeland security, the state emergency
10 management agency, local emergency planning commissions, county offices of emergency
11 management, the department of natural resources, and the state public service commission
12 to protect the utility's generation, distribution, transmission assets, and incremental
13 increases in costs for insuring such assets but only to the extent such insurance cost
14 increases are related to terrorist activities of September 11, 2001, or similar terrorist
15 threats or activities occurring thereafter, by periodic adjustment to the utility's customers
16 bills. Recovery would include security measures for computer systems used in the
17 generation, transmission, and distribution of utilities and other operations and control
18 systems. The application shall be subject to such procedures and conditions, including
19 review, in an expedited manner, of the prudence of the expenditures and the
20 reasonableness of the measures, as the commission deems appropriate. Upon filing a
21 petition pursuant to this section, the commission shall publish a notice of the filing. The
22 contents of such application and request shall be protected from public disclosure as
23 determined by the commission.

24 2. The public service commission, upon application, shall authorize an electric
25 corporation to recover unreimbursed costs for capital projects for required relocation of
26 company facilities due to construction or improvement of a highway, road, street, public
27 way, or other public work by or on behalf of the United States, this state, or any political
28 subdivision of this state, or any entity having the power of eminent domain by periodic
29 adjustment to the utility's customers bills. The application shall be subject to such
30 procedures and conditions, including review, in an expedited manner, of the prudence of

Section 1. A steam heating company having fewer than one hundred customers in
2 **this state may file under the small company rate procedure established by the public**
3 **service commission in 4 CSR 240-2.200 by giving notice to the secretary of the commission,**
4 **the public counsel, each customer, and each gas corporation or electric corporation**
5 **providing utility service in the area. Any customer, gas corporation, or electric corporation**
