AN ACT

To amend chapter 304, RSMo, by adding thereto one new section relating to mobile infrared transmitters, with a penalty provision.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 304, RSMo, is amended by adding thereto one new section, to be
2 known as section 304.079, to read as follows:

**304.079. 1. As used in this section "emergency personnel" means any of the
2 following:**

3 **(1) Any member of the state highway patrol, the state water patrol, any state park
4 ranger, any federal, state, or local law enforcement officer or traffic officer, or any
5 coroner;**

6 **(2) Any person operating an ambulance or other vehicle used for the purpose of
7 transporting emergency medical supplies or organs while performing emergency service;**

8 **(3) Any driver of any wrecker, or tow truck or a vehicle owned and operated by a
9 public utility or public service corporation while performing emergency service;**

10 **(4) Any person transporting equipment designed to extricate human beings from
11 the wreckage of a motor vehicle, but only while transporting such equipment in response
12 to a request from other emergency personnel to transport such equipment to the site of an
13 emergency;**

14 **(5) Any person designated to perform emergency functions for a civil defense or
15 emergency management agency established pursuant to the provisions of chapter 44,
16 RSMo;**

17 **(6) Any authorized employee of the department of corrections, who as a part of the**

18 **employee's official duties, is responding to a riot, disturbance, hostage incident, escape or**
19 **other critical situation where there is the threat of serious physical injury or death,**
20 **responding to mutual aid call from another criminal justice agency in an emergency**
21 **situation or accompanying an ambulance which is transporting an offender to a medical**
22 **facility when such transport is an emergency situation;**

23 **(7) Any person designated to perform hazardous substance emergency functions;**

24 **(8) Any member of an organized fire department, ambulance association, or rescue**
25 **squad, whether paid or volunteer, but only while responding to an emergency fire call, an**
26 **emergency rescue call or an emergency ambulance call or at the scene of an emergency fire**
27 **call, an emergency rescue call, or an emergency ambulance call.**

28 **2. No person other than emergency personnel shall possess a mobile infrared**
29 **transmitter which is capable of changing a traffic control signal as defined in section**
30 **300.010, RSMo.**

31 **3. Any person who violates the provisions of this section shall be guilty of a class**
32 **A misdemeanor.**
