#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Higher Education** (DHE) assume this proposal would have no direct fiscal impact on DHE. However, it may have an impact on the higher education institution specified due to costs incurred if the institutional mission changes. Further, unknown costs would also be incurred by the institution for changes in signage, stationary, and other related changes.

Officials from **Missouri Western State College** assume that the cost would be nominal and could be absorbed from existing local resources.

**Oversight** assumes the name change would be accomplished at nominal cost and would not require additional state appropriations. Oversight has not included any donations or expenditures in the estimated fiscal impact. Oversight also assumes that any additional or unexpected costs incurred due to institutional mission changes would be addressed through the normal higher education budget process.
