ASSUMPTION

The Jasper County Clerk only issued a statement in favor of passage.

Oversight checked with officials of the Secretary of State's Office and determined there are 112 counties that have a County Clerk. The other counties and the City of St. Louis have Boards of Election Commissions. Oversight assumes if each County Clerk were to receive \$7,500 additional salary, the fiscal impact on a statewide basis would be $112 \times 7,500 = 840,000$ annually.
