FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Natural Resources**, **Department of Conservation** and the **Department of Public Safety** - Divisions of **Director's Office**, **Fire Safety** and **Alcohol and Tobacco Control** each state the proposal would not have a fiscal impact on their respective agencies.

Officials from the **Department of Public Safety - State Highway Patrol (MHP)** state they interpret the language in the bill, "made available to any hiring law enforcement agency", to mean MHP would be required to let them view the files. Therefore, MHP anticipates no fiscal impact. If this interpretation is inaccurate and the intent of that statute is that the MHP would have to make copies of the file, there would be a minimal fiscal impact of approximately \$900 a year. However, this cost could be absorbed.

Officials from the **Jefferson City Police Department** state the proposal could result in an unknown amount of future savings by reducing litigations for some departments.

Officials from the **St. Louis Metropolitan Police Department (SLMPD)** assume the proposal could result in a minimal cost increase for providing hard copies if requested from other law enforcement agencies. SLMPD state they currently provide information to the POST

ASSUMPTION (continued)

Commission for all Internal Affairs Division cases (even when police officers leave the department without a final determination).

Officials from the **Columbia Police Department** state that by giving the releasing agency immunity, POST and other inquiring agencies could find out the pertinent details of an officer.

Oversight assumes state law enforcement departments and law enforcement agencies of local governments would realize some insignificant administrative impact. Oversight assumes any impact realized could be absorbed by the affected law enforcement bodies at their current appropriation levels.

Officials from the **Department of Corrections**, **Kansas City Police Department**, and the **Sheriffs of Cole and Boone Counties** did not respond to our request for fiscal impact.

DESCRIPTION

This proposal requires law enforcement agencies to provide the personnel records of any peace officer when the peace officer seeks employment with another law enforcement agency. These records include any uncompleted investigation of alleged acts of the peace officer.

The proposal also requires law enforcement agencies to notify the Peace Officer Standards and Training Commission upon acquiring information that demonstrates the peace officer's unfitness for certification.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
