FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This bill adds the cities of Cameron and Boonville to the cities which may order the abatement of weeds or trash within five business days after notice is sent or posted on the property, when weeds and trash are allowed to grow or accumulate more than once during a season or year. The cost of removal may be billed on a special tax bill to be collected by the Collector with other taxes assessed against the property.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
