FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This bill adds Cameron, Boonville, Sikeston, and Kirksville to the cities which may order the abatement of weeds or trash when allowed to grow or accumulate more than once during a season or year in violation of an ordinance. The cost of removal may be billed on a special tax bill to be remitted to the collector with other taxes assessed against the property.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
