### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

### **DESCRIPTION**

This bill provides that candidates who fail to file campaign finance disclosure reports within 60 days after the due date will be disqualified from seeking the office sought. Within 14 days after actual notice of the proposed disqualification, the candidate may appeal to the Administrative Hearing Commission, which stays the disqualification.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
