FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the State Public Defender** and the **Office of the State Courts Administrator** each assume the proposal would not fiscally impact their respective agencies.

In response to a previous version of this proposal, officials from the **Office of Prosecution Services** assumed any costs arising as a result of the proposal could be absorbed within existing resources.

Officials from the **Department of Public Safety - Division of Fire Safety (DFS)** state this legislation expands the definition of "amusement ride" to include dry slides, portable climbing walls, bungee attractions, and tram-type attractions. It also authorizes DFS to conduct spot safety inspections on rides already permitted, and transfers the program funding to the Elevator Safety Fund.

DFS states this legislation would vastly broaden the scope of the current requirements of the Amusement Ride Safety program. In addition to adding to the types of rides that would be required to be permitted, it would allow DFS staff to spot check rides that had already received a permit. As it is estimated there are 1,050 rides operating in Missouri during the typical amusement ride season, and due to the size of our state, it was determined that two additional

equipped with a vehicle and a laptop computer, along with basic supplies for operating in a field office. Because the amusement ride season is limited to the spring/summer months, the new FTE would perform elevator safety inspections during the remainder of the year. Fees from administering the Amusement Ride Safety program, as well as the additional fees brought into the Elevator Safety Fund from the inspections these FTE would perform during the fall and winter, are estimated to be \$103,110 in FY 2005, \$261,330 in FY 2006 and \$265,000 in FY 2007.

The requested two FTE are Elevator / Amusement Ride Safety Inspectors (each at \$32,592 per year) and are assumed to be funded through the Elevator Safety Fund. DFS assumes the cost of the two FTE, including salary, fringe benefits and expense and equipment would be \$95,542 for FY 2005, and roughly \$120,000 per year thereafter.

DFS assumes the net fiscal impact to the Elevator Safety Fund resulting from the cost of the additional FTE as well as the additional fees generated will be \$7,568 in FY 2005, \$141,337 in FY 2006 and \$142,249 in FY 2007.

DFS assumes a loss of \$15,750 (1,050 rides x \$15 annual permit for each) to the General Revenue Fund from the redirection of the amusement ride permit fees. DFS also estimates a savings of \$1,500 of equipment and expense for the amusement ride permits that is currently in the General Revenue budget.

This proposal could increase Total State Revenues.

FISCAL IMPACT - Small Business

Small businesses that operate any device within the newly expanded definition of "amusement rides" would be fiscally impacted by this proposal.

DESCRIPTION

This proposal makes changes to the laws regarding amusement rides. In its main provisions, it:

(1) Expands the definition of "amusement ride" to include dry slides, bungee cord attractions, climbing walls over ten feet in height (with certain exceptions), and trams, open cars or wagons;

(2) Authorizes the Department of Public Safety to conduct spot inspections of amusement rides without notice whenever the ride is operating and provides for suspension when unsafe conditions are disclosed and reinstatement upon correction and reinspection;

(3) Changes the allocation of collected inspection fees from the General Revenue Fund to the Elevator Safety Fund;

(4) Provides that owners or operators of portable amusement rides must file an itinerary with the Division of Fire Safety no less than 15 days before the ride is open to public use; and

(6) Makes it a class B misdemeanor to knowingly make false statements or representations in documents required in the laws governing amusement rides.

The proposal becomes effective January 1, 2005.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
