### **FISCAL ANALYSIS**

#### **ASSUMPTION**

Officials from the **Office of the State Public Defender** and the **Department of Public Safety - Missouri State Highway Patrol** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Office of the State Courts Administrator** assume the proposal would not fiscally impact the courts.

Officials from the **Office of Prosecution Services** assume costs arising from this proposal could be absorbed with existing resources.

Officials from the **Department of Corrections (DOC)**, state this bill creates the crime of misuse of a power of attorney with penalty provisions up to a class C felony.

DOC states that at this time, they are unable to determine the number of people who would be convicted under the provisions of this bill and therefore the number of additional inmate beds that may be required as a consequence of passage of this proposal. Estimated construction cost for one new medium to maximum-security inmate bed is \$55,000. Utilizing this per-bed cost

provides for a conservative estimate by the DOC, as facility start-up costs are not included and

entire facilities and/or housing units would have to be constructed to cover the cost of housing new commitments resulting from the cumulative effect of various new legislation, if adopted as statute. An increase in commitments depends on the utilization by prosecutors and the actual sentences imposed by the court.

If additional persons are sentenced to the custody of the DOC due to the provisions of this legislation, the DOC will incur a corresponding increase in operational cost either through incarceration (FY03 average of \$38.10 per inmate, per day or an annual cost of \$13,907 per inmate) or through supervision provided by the Board of Probation and Parole (FY03 average of \$3.15 per offender, per day or an annual cost of \$1,150 per offender).

In summary, supervision by the DOC through probation or incarceration would result in additional unknown costs to the department. Eight (8) persons would have to be incarcerated per fiscal year to exceed \$100,000 annually. Due to the narrow scope of this new crime, DOC assumes the impact would be less than \$100,000 per year for their agency.

Officials from the **Office of the Attorney General** did not respond to our request for fiscal impact.

#### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### **DESCRIPTION**

This proposal creates the crime of misuse of a power of attorney where an agent's actions result in the unauthorized disposition of a principal's assets for the benefit of a third party. Misuse of a power of attorney is a class A misdemeanor for the first offense, unless the value of the assets is \$500 or more, in which case it is a class C felony. Second or subsequent offenses are class C felonies.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
