No direct fiscal impact to small businesses would be expected as a result of this proposal.


DESCRIPTION

This legislation designates a portion of U.S. Highway 67 in St. Francois County between State Route 8 in Desloge and State Route 32 in Leadington as the "Deputy Steven R. Ziegler Memorial Highway."
