FISCAL IMPACT - Small Business

This proposal could have a fiscal impact on small real estate businesses due to a possible decrease in litigation expenses.

DESCRIPTION

This proposal provides immunity for real estate licensees in regard to statements made by certain home inspection experts. Real estate licensees will not be subject to any action for information contained in a seller's disclosure unless the licensee is a signatory to false statements, knew prior to closing that certain statements were false, or was reckless as to whether the statements were true or false.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
