### AN ACT

To amend chapter 565, RSMo, by adding thereto one new section relating to human cloning, with penalty provisions.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Chapter 565, RSMo, is amended by adding thereto one new section, to be known as section 565.305, to read as follows:

**565.305. 1. As used in this section, the following words and phrases shall mean:**

(1) "Clone a human being" or "cloning a human being", the creation of a human being by any means other than by the fertilization of an oocyte of a human female by a sperm of a human male;

(2) "Cloned human being", an individual created by human cloning;

(3) "Public employee", any person employed by the state of Missouri or any agency or political subdivision thereof;

(4) "Public facilities", any public institution, public facility, public equipment, or any physical asset owned, leased, or controlled by the state of Missouri or any agency or

10 **political subdivision thereof;**

11 **(5) "Public funds", any funds received or controlled by the state of Missouri or any**  
12 **agency or political subdivision thereof, including, but not limited to, funds derived from**  
13 **federal, state, or local taxes, gifts or grants from any source, public or private, federal**  
14 **grants or payments, or**  
15 **intergovernmental transfers.**

16 **2. No person shall knowingly clone a human being, participate in cloning a human**  
17 **being, or attempt to clone a human being.**

18 **3. No person shall knowingly use public funds to clone a human being or to attempt**  
19 **to clone a human being.**

20 **4. No person shall knowingly use public facilities to clone a human being or to**  
21 **attempt to clone a human being.**

22 **5. No public employee shall knowingly allow any person to clone a human being or**  
23 **to attempt to clone a human being while the person is making use of public funds or public**  
24 **facilities.**

25 **6. Any person who violates any of the provisions of subsections 2 to 5 of this section**  
26 **is guilty of a class B felony.**

27 **7. The laws of this state shall be interpreted and construed to acknowledge on**  
28 **behalf of a cloned human being at every stage of development, all the rights, privileges, and**  
29 **immunities available to other persons, citizens, and residents of this state, subject only to**  
30 **the Constitution of the United States and decisional interpretations thereof by the United**  
31 **States Supreme Court and specific provisions to the contrary in the statutes and**  
32 **constitution of this state.**
