Reported from the Committee on Higher Education March 15, 2005 with recommendation that the bill Do Pass. Referred to the Committee on Rules pursuant to Rule 25(26)(f).

Reported from the Committee on Rules March 17, 2005 with recommendation that the bill Do Pass with no time limit for debate.

Taken up for Perfection April 18, 2005. Bill ordered Perfected and printed.

AN ACT

To amend chapter 160, RSMo, by adding thereto one new section relating to American Sign Language.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 160, RSMo, is amended by adding thereto one new section, to be known as section 160.075, to read as follows:

- 160.075. 1. Any public school or public institution of higher education in this state may offer one or more courses in American Sign Language (ASL). American Sign Language shall be treated as a foreign language for academic credit granting and receiving purposes when ASL is offered by a public school or public institution of higher education in Missouri.**
- 2. Any student enrolled in a public school or public institution of higher education in this state that offers an American Sign Language course or courses as part of the school's or institution's regular curriculum shall receive academic credit for such course or courses if such school or institution provides academic credit for a course or courses in any other foreign language. Nothing in this section shall prohibit a school or institution**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

11 from offering nonacademic credit ASL classes as part of the school's or institution's

13 **3. Any student enrolled in a public school or public institution of higher education**
14 **in this state that offers an American Sign Language course or courses may earn academic**
15 **credit for such course by completing the course with a passing grade or by demonstrating**
16 **a proficiency in ASL at a level of competence equal to that taught in such course.**

17 **4. Academic credit received for taking an ASL course or demonstrating proficiency**
18 **in ASL shall be counted toward satisfaction of any foreign language or language arts**
19 **requirements of the public school or public institution of higher education, including any**
20 **foreign language or language arts entrance requirements of any public institution of higher**
21 **education.**

22 **5. Nothing in subsection 4 of this section shall be construed as limiting the ability**
23 **of individual departments in public institutions of higher education located in the state of**
24 **Missouri from establishing specific departmental language requirements for majors that**
25 **cannot be met by American Sign Language.**

26 **6. The Missouri commission for the deaf and hard of hearing and the Missouri**
27 **American Sign Language teachers association shall provide assistance, advice, and**
28 **guidance on the development, establishment, and teaching of American Sign Language**
29 **course in Missouri public schools and public institutions of higher education as needed and**
30 **requested.**
