FISCAL ANALYSIS

ASSUMPTION

Officials of the **Office of Secretary of State - Elections Division** assume no fiscal impact to their office.

St. Louis County Board of Election Commission stated that cost is indeterminate, because they have no way of knowing how many additional voters would utilize advance voting. Officials assume they would have additional cost from operating and staffing approximately four different off-site voting locations. Officials stated that although additional voting sites are not required, the voting public would demand it. Additional site would require a significant outlay for additional personnel.

Kansas City Board of Election Officials assume this proposal would have significant fiscal impact. Officials assume they would need additional staff some part-time, some full-time, and site rental, equipment, and programming expense all totaling an estimated \$250,000 annually. Some elections cost would be less.

ASSUMPTION (continued)

Platte County Board of Election Commission assume they would need additional staff, equipment, postage and supplies totaling \$52,017 in FY 2006; and \$51,292 total in FY 2007; and \$51,292 in FY 2008.

Officials of the **Jasper County Clerk's Office** assume they would need additional staff, and some additional supplies. Officials did not submit an estimate of cost.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

Currently, absentee voting is permitted only for certain reasons, and applications for absentee ballots must be received by 5:00 p.m. on the Wednesday immediately prior to an election. This bill changes the terminology from "absentee" to "advance" voting, allows advance voting for any reason, and extends the application deadline for advance voting to 5:00 p.m.on the Friday

than the election authorities' offices as additional sites to apply for and vote advance ballots in person.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
