FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of State Public Defender** assume the proposed legislation would have no fiscal impact on their agency.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Office of Prosecution Services** assume the proposal would not have a significant direct fiscal impact on county prosecutors.

Officials from the **Department of Corrections (DOC)** assume the proposal eliminates the Board of Probation and Parole's (P&P) right to convert consecutive sentences to concurrent sentences and deletes the exception for amendatory law applying when the penalty for an offense would be reduced.

Deleting the amendatory law provision eliminates incarcerated offenders; rights to have their sentence reduced due to a change in the law. There is no basis on which to estimate how much potential saved prison time could have occurred in the future and would now be eliminated.

ASSUMPTION (continued)

DOC assumes although the P&P Board has had the power to convert consecutive sentences for approximately ten years, they have never exercised their authority to do so. Therefore, DOC assumes there is no fiscal impact should this bill be passed into law.

FISCAL IMPACT - Small Business

DESCRIPTION

The proposed legislation would eliminate offender's right to have a sentence reduced by any alteration of the law. The proposal would also eliminate the board of probation and parole's right to convert consecutive sentences to concurrent sentences in certain circumstances.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
