FISCAL ANALYSIS

ASSUMPTION

Officials of the **Office of Secretary of State** stated that statewide newspaper publication of state statutes cost approximately \$1,289 per column inch based on estimate provided by the Missouri Press Service x 3 for multiple printings as required by the Constitution and state statute = \$3,867 per column inch. Estimate total number of inches for this amendment to be 15 inches, which includes title header and certification paragraph. $$3,867 \times 15$ inches = \$58,005.
