FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Labor and Industrial Relations** assume this proposal would exclude certain motor carriers from workers compensation insurance requirements and result in revenue reductions to the Workers' Compensation Fund and the Second Injury Fund of less than \$50,000 per year for each fund.

Officials from the **Department of Economic Development** and the **Department of Transportation** (MODOT) assume this proposal would have no fiscal impact to their organizations. Officials from MODOT stated the proposal could result in savings to motor carriers as a result of the proposed exemption from workers' compensation insurance requirements.
