FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Public Safety** – **Missouri State Highway Patrol** and the – **Division of Fire Safety** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of the State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Office of Prosecution Services** assume the proposal would not have a significant direct fiscal impact on county prosecutors.

In response to a previous version of the proposal (Perfected HB 196, LR # 0474-01A), officials from the **Office of State Public Defender (SPD)** assumed existing staff could provide representation for those few cases arising where indigent persons were charged due to the increased statute of limitations for arson in the first and second degrees and knowingly burning or exploding. Passage of more than one bill increasing penalties on existing crimes or creating new crimes would require the SPD to request increased appropriations to cover the cumulative cost of representing indigent persons accused in the now more serious cases or in the new additional cases.

<u>ASSUMPTION</u> (continued)

Officials from the **Department of Corrections (DOC)** state that at this time, they are unable to determine the number of people who would be convicted under the provisions of this bill and therefore the number of additional inmate beds that may be required as a consequence of passage of this proposal. Estimated construction cost for one new medium to maximum-security inmate bed is \$55,000. Utilizing this per-bed cost provides for a conservative estimate by the DOC, as facility start-up costs are not included and entire facilities and/or housing units would have to be constructed to cover the cost of housing new commitments resulting from the cumulative effect of various new legislation, if adopted as statute.

If additional persons are sentenced to the custody of the DOC due to the provisions of this legislation, the DOC will incur a corresponding increase in operational cost either through incarceration (FY04 average of \$38.37 per inmate per day, or an annual cost of \$14,005 per inmate) or through supervision provided by the Board of Probation and Parole (FY03 average of \$3.15 per offender per day, or an annual cost of \$1,150 per offender).

In summary, supervision by the DOC through probation or incarceration would result in additional unknown costs to the department. Eight (8) persons would have to be incarcerated per fiscal year to exceed \$100,000 annually. Due to the narrow scope of this new crime, DOC assumes the impact would be less than \$100,000 per year for their agency.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposal lengthens from three years to five years the statute of limitation for the crimes of arson in the first degree, arson in the second degree, and knowingly burning or exploding property.

The proposal would expand the crime of arson in the first degree to include damage to a structure by fire or explosion in an attempt to produce methamphetamine, a class A felony.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
