FISCAL ANALYSIS

ASSUMPTION

Officials from the **Governor's Office** and the **Missouri Senate** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of State Courts Administrator** assume the proposal would have no fiscal impact on the courts.

Officials from the **Office of the Secretary of State (SOS)** assume statewide newspaper publication of state statutes cost approximately \$1,289 per column inch based on estimates provided by the Missouri Press Service. There would be three printings at approximately 5 inches each, which includes title header and certification. SOS estimates the total cost of the proposal to be \$19,335 in fiscal year 2007. These costs are based on 2004 figures and are subject to change. The proposal would be on the ballot for the November 2006 general election.
