FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Revenue** and the **Department of Public Safety - Office of the Adjutant General** each assume the proposal will not fiscally impact their respective agencies.

Officials from the **City of Knob Noster** assume they will incur costs from this proposal associated with sending a building inspector out to properties for inspection and compliance issues. The city currently has one inspector, with a gross salary of \$29,610 per year. The City assumes cost associated with one-fourth of the inspector's time to be \$7,404 per year.

Oversight assumes the proposal (in Section 41.1013) allows the City of Knob Noster, by ordinance, to "adopt and enforce regulations governing zoning, planning, subdivision and building within all or any portion of the unincorporated area...." Therefore, since the language is permissive to Knob Noster, Oversight will not reflect a cost to the city as a result of this proposal.

ASSUMPTION (continued)

In response to a similar proposal from this year (SB 252), officials from the **Department of Economic Development (DED)** assumed they would be required to provide administrative support and staff for the 7 member commission as well as set up at least 4 meetings per year. DED is to provide administrative costs and staffing. The costs are projected on the minimum number of meetings and could be higher. Commission staff support to be provided by DED could be a minimum of some additional overtime for DED employees but could require FTE. The cost for the staff support would be dependent on the activity of the committee. The administrative costs other than meetings is unknown and would again be dependent on the desires of the commission. DED projected the need for one person 1/2 time to coordinate the activities of the program and work with commissioners. DED would also incur expenses in setting up and organizing the meetings and implementing the commission directives. Funding is to be provided through appropriation and expenditure of more than 10% of the funding at one time requires specific procurement. Exact cost of administration and expenses would be unknown until the Commission developed their strategic plan. Meeting costs are projected but other costs will be unknown.

DED projected a 1/2 time FTE classified as an Economic Development Incentive Specialist II (at \$39,288 annually). DED would have to provide meeting space for the 7 commission members plus expenses. Four meetings are projected per year. Cost include over night lodging (\$70), mileage (\$.345 x 240 RT = \$82.80), and one days meals (\$45.00 for 3) plus print, meeting room, etc. for each meeting (\$250). The total cost for 7 members is estimated to be \$1,634.60 (7 X (\$70 + \$82.8 + \$45) each plus \$250) each meeting. Advertising and promotion costs are anticipated but unknown. Cost to put on the celebration are also projected as an unknown. Costs for any contract studies, reports, or equipment is unknown.

In summary, DED anticipated expenses of roughly \$45,000 to an unknown amount to be spent from the General Revenue Fund as a result of this proposal.

Oversight assumes DED will not require the additional 1/2 FTE nor the related expenses to fulfill its duties as specified in the proposal. If Oversight is incorrect in this assumption, Oversight assumes DED will request the additional FTE and expenses through future budgetary procedures. Oversight also assumes DED will reimburse the commission members for their actual and necessary expenses, including mileage, lodging, and meals, which Oversight estimates to total roughly \$9,100 per year.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposal establishes the Missouri Military Preparedness and Enhancement Commission to design and implement measures to protect, retain, and enhance the present and future mission capabilities of military posts and bases around the state.

The commission's duties will include preparing a biennial strategic plan and an annual report. The seven-member commission will meet quarterly, or more often if additional meetings are deemed necessary by the chair. Funding for the commission will be by appropriation, and the Department of Economic Development will provide administrative support staff.

The City of Knob Noster is allowed to adopt and enforce regulations regarding zoning and planning within the unincorporated area that extends two miles beyond the city's corporate limits. Zoning and planning ordinances affecting the unincorporated areas can be less restrictive than the ordinances affecting areas within the city's limits.

DESCRIPTION (continued)


For the purposes of student resident status, military personnel stationed in Missouri, as well as their spouses and minor children, will be regarded as Missouri residents.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
