DESCRIPTION

The proposal defines surgery as including the use of lasers, pulsed light, radio frequency, or medical microwave devices for the purpose of altering human tissue.

The proposal establishes criteria for delegating procedures involving lasers, pulsed light, and radio and microwaves to persons that are not licensed physicians.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
