#### FISCAL IMPACT - Small Business

This proposal could impact small businesses which would need to schedule veterans' days off and assign other employees to work on Veterans Day.

#### **DESCRIPTION**

This proposal would give veterans employed in Missouri the right to not work on Veterans Day without fear of reprisal from their employer. Any veteran could request not to work on Veterans Day and any employer in this state would be required to grant such request from a veteran as long as the following conditions are met:

- The veteran would submit proof of his or her status as a veteran to the employer a minimum of thirty calendar days prior to the first Veterans Day that he or she is requesting off.
- The veteran would submit a request not to work on a particular Veterans Day, in writing, a minimum of thirty calendar days prior to that particular Veterans Day.
- No employer could take any adverse action regarding such veteran's employment as a result of exercising his or her right to not work on Veterans Day.
- Any veteran could exercise his or her right to not work on Veterans Day without loss of any right or benefit to which the veteran employee is entitled.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
