FISCAL ANALYSIS

ASSUMPTION

Officials with the **Missouri Department of Transportation (MoDOT)** assume that signs designating the highway name proposed in this legislation would be paid for by private donations. MoDOT is unsure the amount of the private donation, and assume it would have to pay any portion of cost not funded by private donations out of the Road Fund. MoDOT assumes the total cost of the signage included in this legislation to be \$655.

Oversight assumes that sufficient private funds would be raised to cover the costs of the signs.
