### FISCAL ANALYSIS

#### ASSUMPTION

**In response to identical legislation (1234-01) the following fiscal impact statements were made.**

Officials of the **Department of Economic Development - Professional Registration** stated that the Missouri Coroner's and Medical Examiners Association is not regulated by the Division of Professional Registration and would have no fiscal impact.

**Oversight** assumes the Missouri Coroner's and Medical Examiners Association is a private not a governmental organization and assumes this proposal does not require county governments to pay registration fees for the assistants or Deputy Coroners, therefore Oversight assumes no State or Local fiscal impact.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


DESCRIPTION

This act requires all Deputy Coroners and assistants to the Coroner to register with the Missouri Coroners and Medical Examiners Association immediately after being appointed but before they begin their duties.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
