ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** state this proposal will have no fiscal impact on their agencies or school districts.

Officials from the **Columbia School District** state this proposal would have minimal fiscal impact on their district.

Officials from the **Sikeston School District** indicate this proposal will have no fiscal impact on their district.

Officials from the **Kansas City Missouri School District** state that additional cost could be incurred if legal representation is required for the hearings on a request for waivers.

Based on responses from DESE and other school districts, **Oversight** assumes any negative fiscal impact associated with this proposal would be minimal and could be absorbed with existing resources.

Officials from the Saint Louis, Springfield, St Joseph, and Lee's Summit School Districts did not respond to a request for fiscal note response.

DESCRIPTION

Current law requires district boards to convene a hearing in order to determine whether a pupil shall be granted a waiver of certain registration requirements. This proposal would allow districts to convene a committee of their board in order to rule on such residency waiver requests.
