### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials with the **Department of Transportation (MoDOT)** assume this proposal states that highways signs on selected highways in Greene County that designate entry into the county shall contain the message: "Welcome to Greene County – Home of Governor Matt Blunt". MoDOT states that this act would result in a possible impact of a \$4,022 cost for 8 signs on Highways 13, 44, 60, and 65 entering Greene County.

Since no other funding source is listed, MoDOT assumes the cost of the these signs would be incurred by the Road Fund. At the end of Governor Blunt's tenure in office, MoDOT assumes these signs would have to all be removed and replaced with standard county line signs, resulting in additional fiscal impact to MoDOT.

**Oversight** assumes that private funds could potentially be raised and utilized for the signs mandated by the act, negating any fiscal impact to MoDOT. Otherwise, MoDOT would bear the costs of the signs.
