DESCRIPTION

After August 28, 2007, this proposal requires all applicants for licensure as a professional counselor to provide the Committee for Professional Counselors with evidence of the completion of a minimum of three hours of graduate-level course work in diagnostic systems in the curriculum leading to their degree. The committee is authorized to establish continuing education requirements for professional counselors to maintain and renew their licenses.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
