FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education, Coordinating Board for Higher Education, House of Representatives, Missouri Senate, and the Office of Lieutenant Governor** state this proposal will have no fiscal impact on their respective agencies.

Officials from the **Office of the Secretary of State (SOS)** assume statewide newspaper publication of state statutes cost approximately \$1,289 per column inch based on an estimate provided by the Missouri Press Service. Three printings are required by the Constitution and state statute; therefore publication cost would total \$3,867 per column inch. SOS estimates the total number of column inches for this amendment to be 4 inches including title header and certification paragraph. ($\$3,867 \times 4 = \$15,468$). Costs are based on 2004 figures and are subject to change.

In response to a similar proposal from this session (HJR 5), officials from the **Office of the Governor** state there would be no fiscal impact to their office.

Oversight assumes that the election would be held at the regularly scheduled general election and assumes no local fiscal impact.

FISCAL IMPACT - Small Business

DESCRIPTION

This proposed constitutional amendment prohibits, upon voter approval, the Governor from reducing appropriations for elementary, secondary, and higher education.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
