#### 93RD GENERAL ASSEMBLY

0010S.03C 2005

#### **AN ACT**

To appropriate money for the expenses, grants, refunds, and distributions of the Department of Mental Health, the Board of Public Buildings, the Department of Health and Senior Services, and the several divisions and programs thereof, the Missouri Health Facilities Review Committee, the Commission for the Missouri Senior Rx Program, and the Office of Administration to be expended only as provided in Article IV, Section 28 of the Constitution of Missouri, for the period beginning July 1, 2005 and ending June 30, 2006.

Be it enacted by the General Assembly of the state of Missouri, as follows:

There is appropriated out of the State Treasury, to be expended only as provided in 2 Article IV, Section 28 of the Constitution of Missouri for the purpose of funding each

- 3 department, division, agency, and program enumerated in each section for the item or items
- 4 stated, monies are not appropriated for coverage of medical assistance provided after August 27,
- 5 2005, for adults receiving old age assistance benefits or permanently and totally disabled benefits
- 6 whose income exceeds eighty-five percent (85%) of the federal poverty level. Monies are not
- 7 appropriated for coverage of medical assistance provided after August 27, 2005, for persons
- 8 receiving benefits under RSMo 208.146. Monies are not appropriated for coverage of medical
- 9 assistance provided after June 30, 2005, for adults receiving benefits under the Medical
- 10 Assistance for Families program whose income exceeds fifty percent (50%) of the federal
- 11 poverty level, and for no other purpose whatsoever chargeable to the fund designated for the
- 12 period beginning July 1, 2005 and ending June 30, 2006, as follows:
