### AN ACT

To authorize the governor to convey property owned by the state in the county of Phelps.

Be it enacted by the General Assembly of the state of Missouri, as follows:

- Section 1. 1. The governor is hereby authorized and empowered to sell, transfer, grant, and convey all interest in fee simple absolute in property owned by the state in the county of Phelps to the City of St. James. The property to be conveyed is more particularly described as follows:
- 5 A fractional part of the West Half of the Northwest Quarter of Section 20,
- Township 38 North, Range 6 West of the 5th P.M. described as follows:
- 7 Beginning at the Northeast Corner of the Southwest Quarter of the
- 8 Northwest Quarter of said Section 20; thence South 0°10'30" West, 156.20
- 9 feet along the East Line of said Southwest Quarter of the Northwest Quarter
- to a point on the southernly line of a parcel described in Phelpbs County
- Deed Records at Book 39, Page 544; thence South 55°12'40" West, 104.14
- 12 feet, and, South 55°19'30" West, 811.47 feet, and, South 53°16'30" West,
- 13 352.69 feet, all along said southernly line to the easterly right of way of
