AN ACT

To repeal sections 301.301, RSMo, and to enact in lieu thereof two new sections relating to stolen license plate tabs.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 301.301, RSMo, is repealed and two new sections enacted in lieu 2 thereof, to be known as sections 301.301 and 301.302, to read as follows:

301.301. Any person replacing a stolen license plate tab may receive at no cost up to two

2 sets of two license plate tabs per year when the application for the replacement tab is 3 accompanied with a police report that is corresponding with the stolen license plate tab.

301.302. A citation shall not be issued to any person stopped by law enforcement

2 for a missing license plate tab or tabs if such person indicates that the tab or tabs have been

- 3 stolen and a check on such person's vehicle registration reveals that the vehicle is properly
