AN ACT

To repeal section 227.345, RSMo, and to enact in lieu thereof eight new sections relating to the establishment of memorial highways and bridges.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 227.345, RSMo, is repealed and eight new sections enacted in lieu
2 thereof, to be known as sections 227.305, 227.345, 227.359, 227.375, 227.377, 227.379,
3 227.384, and 227.390, to read as follows:

227.305. The portion of state highway M within Washington county which is
2 **located within the city limits of Irondale shall be designated the "Trooper Robert Kolilis**
3 **Memorial Highway". The department of transportation shall erect and maintain**
4 **appropriate signs designating such highway, with the costs to be paid for by the Missouri**
5 **State Troopers' Association.**

227.345. The portion of interstate 44, **except for the portion of such interstate**
2 **designated under section 227.379**, located in a county of the third classification without a

3 township form of government and with more than thirty-one thousand but less than thirty-one
4 thousand one hundred inhabitants shall be designated the "Edwin P. Hubble Memorial
5 Highway".

227.359. The bridges on state highway 60 crossing the Current River that are
2 located within the city limits of Van Buren shall be designated individually as the "Sgt.
3 Dewayne Graham, Jr. Memorial Bridge MO State Hwy Patrol". The bridges shall be
4 collectively designated as the "Sgt. Dewayne Graham, Jr. Memorial Bridges MO State
5 Hwy Patrol". The department of transportation shall erect and maintain appropriate signs
6 designating such bridges, with the costs to be paid for by the Missouri State Troopers'
7 Association.

227.375. The portion of U.S. Highway 54 located within Camden county from the
2 eastern city limits of Macks Creek to the western city limits of Camdenton shall be
3 designated the "Trooper Ross S. Creach Memorial Highway". The department of
4 transportation shall erect and maintain appropriate signs designating such highway, with
5 the costs to be paid for by the Missouri State Troopers' Association.

227.377. The portion of U.S. Highway 60 from the intersection of state route MM
2 to the intersection of state highway 181 in Texas County shall be designated the "Trooper
3 D. Kevin Floyd Memorial Highway". The costs for such designation shall be paid by the
4 Missouri State Troopers' Association.

227.379. The portion of Interstate 44 from mile marker 91 to mile marker 94 in
2 Webster County shall be designated the "Corporal Jay Sampietro MO State Highway
3 Patrol Memorial Highway". The department of transportation shall erect and maintain
4 appropriate signs designating such highway, with the costs to be paid for by the Missouri
5 State Troopers' Association.

227.384. The two-mile portion of interstate highway 44 heading east from the U.S.
2 Highway 50 intersection, contained in Franklin County, shall be named the "Trooper
3 Ralph Tatoian Memorial Highway". The department of transportation shall erect and
4 maintain appropriate signs designating such highway, with the costs to be paid by the
5 Missouri State Troopers Association.

227.390. The portion of interstate 70 between mile marker 144 and mile marker 155
2 in the county of the first classification with more than forty thousand seven hundred but
3 fewer than forty thousand eight hundred inhabitants, except where otherwise designated,
4 shall be designated the "Missouri Fire Fighters' Memorial Highway". The department of
5 transportation shall erect and maintain appropriate signs designating such highway, with
6 the cost of such signs to be paid by the Fire Fighters Association of Missouri.
