### FISCAL ANALYSIS

### **ASSUMPTION**

Officials from the **Department of Revenue (DOR)** state there are approximately 2,055 Purple Heart Plate registrations. It is assumed that approximately 10% of these owners will apply for additional sets of plates (206). This proposal will require DOR to incur costs for additional plates/tabs and notifications costs (including postage) in the amount of \$2,210 for FY 2007 (General Revenue Fund) for the first year only. After the first year DOR does not anticipate an increase in applications for additional plates.

Assuming there is an increase in the number of purple heart applications as indicated above, there will be an increase in Highway/Cities/Counties funding as a result of the \$15 specialty plate fee.  $15 \times 206 = 3,091$ . This increase would be only for the first year of implementation. After the first year, DOR does not anticipate an increase in applications for additional plates.

The increase in revenue by funds would be:

- \$2,318 =Highway funds (75%)
- \$464 = Cities (15%)
- $\frac{\$309}{\$3,091}$  = Counties (10%)

# **Oversight** assumes DOR can absorb the costs estimated in the proposal within existing resources. However, the addition of similar proposals would cause DOR to request additional funding to cover the cumulative effect of the proposals.
