#### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### **DESCRIPTION**

Currently, a student who is wearing any emblem, insignia, or garment in a nondisruptive manner cannot be asked to remove it. This proposal restricts the emblem, insignia, or garment to a religious one. However, if the emblem or insignia is placed on a garment that the school has prohibited as contrary to its educational mission, the student may be asked not to wear the garment again.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
