#### FISCAL ANALYSIS

### **ASSUMPTION**

Officials from the **Department of Health and Senior Services** and the **Department of Social Services** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Department of Revenue** assume that this legislation will require programming changes to the Missouri Driver License (MODL) system, Central Driver Information System (CDIS) and Missouri Electronic Driver License (MEDL; also referred to as Over The Counter – OTC) software. These changes will be necessary to allow the temporary lawful presence exemption and to issue a temporary instruction permit or temporary driver license to the individual with an expiration not to exceed six months. These programming changes will need to be designed and tested. In addition, procedures, website and other documents listing acceptable documents for proof of lawful presence must be revised.
