FISCAL ANALYSIS

ASSUMPTION

Officials of the **Department of Revenue-Sales Tax Division** assume no fiscal impact.

Officials of the Pulaski County assume no fiscal impact.

Oversight assumes this proposal is permissive and requires action by the governing body with voter approval before any fiscal impact would be realized. **Oversight** assumes if the voters would approve a sales tax allowed by this proposal, there would be income for the purpose of constructing a shelter for women and children. **Oversight** assumes there would be positive fiscal impact to the State General Revenue Fund from the 1% collection fee of the sales tax.

Oversight will show fiscal impact to the General Revenue Fund as \$0 to Unknown. Since it is not known if voters would approve a sales tax, fiscal impact to the Fund could be \$0. **Oversight** assumes if a tax were approved by the voters, there would be income to the Pulaski County Shelter Fund, and there would be the cost of constructing a shelter. **Oversight** assume cost would not exceed income. For the purposes of this fiscal note, **Oversight** will show fiscal impact to local government as \$0.

DESCRIPTION

This bill authorizes Pulaski County to impose, upon voter approval, a sales tax of one-eighth of 1% to fund construction of a women's and children's shelter. The sales tax will expire three years after its effective date unless repealed sooner.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
