## FISCAL ANALYSIS

## ASSUMPTION

Officials of Greene County, Platte County, Jefferson County, Nodaway County, Jasper County, Boone County, and Cass County assume no fiscal impact.

Officials of **Clay County- Office of Collector** assume this proposal would require the Collector to send every homeowner a bill, which would have considerable cost to the county. Officials stated that much of their collections are sent and received electronically. Officials stated they currently do not send homeowners a bill that escrow their taxes and insurance. Homeowners pay that bill monthly. Officials assume they would have additional cost of postage, printing tax related forms, programming cost etc. which would have an estimated annual cost of \$200,000.

**Oversight** will show fiscal impact as \$0 to Unknown to Counties.

**Oversight** sent St. Louis County, Jackson County, Callaway County, Johnson County, Marion County, St. Charles County, Warren County and others a request for a response, however, they have yet to respond. **Oversight** assumes no state fiscal impact.
