### FISCAL ANALYSIS

#### ASSUMPTION

Officials of the **Office of Secretary of State - State Librarian** assumes no fiscal impact to the state.

**Oversight** assumes this proposal to be permissive. Before any fiscal impact would be realized by any political subdivision, the governing body of a county would have to pass an ordinance or order declaring that any fees paid to any library district of which the city or county is a part, shall be designated solely to libraries within the city or county. This proposal states that the order or ordinance would not become effective unless approved by voters of the district.

**Oversight** assumes this proposal as written would have no fiscal impact to local government.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


DESCRIPTION

This bill authorizes the governing bodies of New Madrid County and the cities of Sikeston and Miner to require by ordinance or order that any library fees paid to any library district of which the county or city is a part must be designated solely to libraries within that county or city. The ordinance or order would not become effective unless approved by a public vote.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
