FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of State Courts Administrator (CTS)** assume the proposed legislation would expand small claims court jurisdiction to \$5,000.

CTS assumes there may be some increase in the total volume of civil case filings. In FY 05, there were 16,060 small claims filings and 175,315 chapter 517 civil filings. The simpler small claims process may result in a shift in some civil cases into small claims court.

Court clerks are required to assist parties with filing documents and advise them with respect to process (and are exempt from prosecution for practicing law without a license). This is very time consuming. Small claims cases require more time to try without lawyers.

CTS assumes there may well be an increase in the workload of the courts. Any significant increase will be reflected in future budget requests.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

The proposed legislation increases the amount in controversy from under \$3,000 to under \$5,000 in cases that small claims courts have jurisdiction.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
