DESCRIPTION


This legislation designates the following portions of Interstate and Highway as memorial highways for fallen State Troopers:

- A portion of State Highway M, within the limits of the City of Irondale, in Washington County as the "Trooper Robert Kolilis Memorial Highway."
- A portion of U. S. Highway 54 located within Camden County from the eastern limits of the City of Macks Creek to the western limits of the City of Camdenton as the "Trooper Ross S. Creach Memorial Highway."
- The bridges on State Highway 60 over the Current River located within the limits of the City of Van Buren as the "Sgt. Dewayne Graham, Jr. Memorial Bridge MO State Hwy Patrol."
- A portion of U. S. Highway 60 from the intersection of State Route MM to the intersection of State Highway 181 in Texas County as the "Trooper D. Kevin Floyd Memorial Highway."
- The portion of Interstate 44 from mile marker 92 to mile marker 94 in Greene County as the "Corporal Jay Sampietro MO State Highway Patrol Memorial Highway."

This legislation is not federally mandated, would not duplicate any Program and would not require additional capital improvements or rental space.
