## FISCAL ANALYSIS

#### ASSUMPTION

Officials from the **Department of Elementary and Secondary Education (DESE)** state this proposed legislation will have no fiscal impact on their agency or on local school districts.

Officials from the following school districts stated there would be no fiscal impact to their districts resulting from this proposed legislation: **Columbia, Parkway,** and **Kansas City.** 

Officials from the **Francis Howell School District** stated there could be a fiscal impact to their district if there was a conflict between the effective date of the legislation and the date when any membership fees would be due to a statewide activities association.

**Oversight** assumes, upon passage of this proposed legislation, school districts that may belong to organizations with restrictions outlined in the proposal would no longer maintain membership in such organizations, therefore incurring no additional expenses other than those already paid out.

## FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### DESCRIPTION

This proposed legislation prohibits public schools from joining or retaining membership in any statewide activities association that has rules which would prevent any public school student from participating in school sports at the school where they pay tuition or any public school student with good attendance from participating in any school activity at the school where they pay tuition.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
