DESCRIPTION

This bill allows the governing body of any municipality or county to authorize its employees or agents to stand in a road to solicit charitable contributions. The employee or agent must make written application at least 11 days before soliciting and must provide proof of liability insurance. The governing body may require payment of a reasonable fee.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
