DESCRIPTION


This bill authorizes drainage district boards to impose an annual processing fee for assessed tracts when the board determines that the costs of preparing and processing the district's maintenance tax statement exceed the amount of tax imposed. The fee would be set by the Board of Supervisors at the meeting in which the board sets the maintenance tax under Section 242.490.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
