FISCAL ANALYSIS

ASSUMPTION

Officials from the **State Auditor's Office** assume the proposal would have no fiscal impact on their agency.

In response to a previous version of the proposal (HJR 31, LR # 3615-01), officials from the **Office of the Governor** assumed the proposal would have no fiscal impact on their agency.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Office of the Secretary of State (SOS)** assume statewide newspaper publication of state statutes cost approximately \$1,752 per column inch, based on an estimate provided by the Missouri Press Service. SOS assumes there would be three printings, as required by the state Constitution and state statutes. SOS estimates the total number of inches for this amendment to be 10 inches, which includes the title header and certification paragraph. SOS estimates the total cost of the proposal to be \$52,560 (\$1,752 x 3 x 10). This cost would be incurred in FY 07.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

The proposed constitutional amendment prohibits, upon voter approval, the Missouri Supreme Court or any inferior court of the state from instructing or ordering the state, county, city, or any political subdivision to levy or increase taxes. The proposal also prohibits any Missouri court from instructing or ordering the state, county, city, or any political subdivision on how to spend, allocate, or budget fiscal resources in a manner inconsistent with duly enacted and effective legislation.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
