### FISCAL ANALYSIS

#### ASSUMPTION

Officials of the **Department of Public Safety - Fire Safety** assume no fiscal impact to their department.

Officials of the **Office of Director of Administration of St. Louis County** assumes no fiscal impact.

Officials of the **Central County Fire & Rescue** assumes this proposal would have no fiscal impact on fire districts outside of Jefferson County.

Officials of **Cass County Commission** assume no fiscal impact.

Officials of **Jasper** and **Hickory** counties assume no fiscal impact.

**Oversight** sent response request to Jefferson County and to Fire Protection Districts in Jefferson County, however, no response was issued.

ASSUMPTION (continued)

**Oversight** assumes this proposal removes a prohibition on fire districts in Jefferson County from participating in the residential construction regulatory system. **Oversight** does not require any new duties of fire district. **Oversight** assumes the decision to regulate would be discretionary; therefore, **Oversight** assumes no state or local fiscal impact.

FISCAL IMPACT - Small Business

DESCRIPTION

This bill repeals the law that prohibits fire protection districts from adopting or implementing a residential construction regulatory system if a municipality in Jefferson County adopts or implements a system within the municipality's jurisdiction.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
